The establishment of a new scientific chair at the FDSPT

- The official inauguration of the ALECSO Chair for International Commercial Arbitration took place on October 3, 2022, at the headquarters of ALECSO, in the presence of the President of the University of Tunis El Manar, the Director-General and Executive Director of ALECSO, the President of the Court of Cassation, the Dean of the Faculty of Law and Political Science of Tunis (FDSPT), as well as experts, arbitration practitioners, academics, researchers, and lawyers. During the inaugural conference, Professor Najet Brahmi Zouaoui, holder of the Chair from FDSPT, presented the role of the Chair and its significance in training and research outcomes concerning international commercial arbitration.

The ALECSO Chair (FDSPT-UTM)

- The ALECSO Chair for International Commercial Arbitration (CAACI) was established by the Arab Organization for Education, Culture and Sciences (ALECSO) on April 22, 2022, following the accreditation of Ms. Najet Brahmi Zouaoui, a professor at the Faculty of Law and Political Sciences of Tunis.
- The establishment of the Chair falls within the framework of international cooperation between ALECSO and the member countries of the League of Arab States. It aligns with ALECSO's activities as an Arab organization dedicated to promoting education and sciences in Arab countries.
- The ALECSO Chair for International Commercial Arbitration is the first of its kind in the Arab world, where 33 other chairs operate in various fields under the auspices of ALECSO.

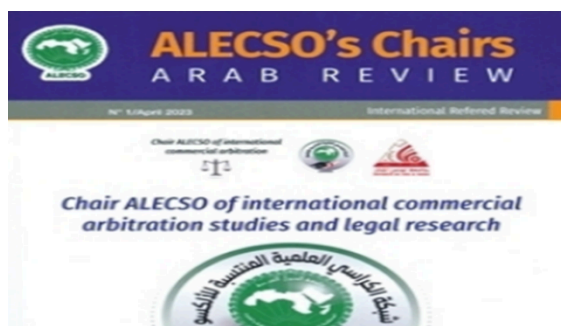
